SUBJECT: INSPECTION OF VERTICAL FIN STRUCTURE.

COMPLIANCE: SEE BELOW.

PURPOSE: Service reports have revealed (3) vertical fin upper trailing edge tubes were

> found to have cracks or breaks at the end of the cluster star gusset. This Service Bulletin is being issued to provide the operator with an improved

vertical fin to prevent future difficulties.

INSTRUCTIONS:

PART 1 TO BE ACCOMPLISHED WITHIN NEXT TEN (10) FLIGHT HOURS AND

EVERY TEN (10) FLIGHT HOURS THEREAFTER.

a. Visually inspect vertical fin upper trailing edge tube, in the area just above the upper flying wire attachment, to determine if any cracks or breaks are present. This may be done by manually depressing the fabric on each side to feel any cracks. Also the upper tube may be rotated left and right to check for any motion in the vicinity of the cluster star gusset.

- b. If cracks or breaks are detected, proceed to Part II.
- c. If no cracks are detected, re-inspect in accordance with Paragraph a. above every ten (10) flight hours until the vertical fin is replaced in accordance with Part II.
- d. Install vertical fin Part No. 54030-96 in accordance with Part II within fifty (50) hours flying time from the date of this Service Bulletin.

PART II TO BE ACCOMPLISHED PRIOR TO NEXT FLIGHT

- a. Remove vertical fin.
- b. Install vertical fin Part No. 54030-96 using the same hardware removed from Step a.
- c. Re-rig vertical fin and rudder in accordance with instruction outlined in the Airplane Maintenance Manual, Section VII. Proceed to AIRCRAFT RECORDS.
- d. Fill out and mail compliance card.
